

Discussion

As you may recall, staff presented a draft contract at the February 11, 2021 Board meeting from CAL FIRE in the amount of \$200,000 to conduct fuel reduction activities around Ruth Lake which the Board approved. See copy of February Minutes attached. CAL FIRE's internal process to finalize the contract took several months and they have modified the original contract amount. The actual contract that has now been proposed is for \$500,000. See attached contract.

The primary uses of the fuel reduction funds are as follows listed in order of priority:

- 1. Implement Defensible Space (Fire Safe Zone) around Lease Lot structures that did not burn in the August Complex Fire as stated in the HBMWD Board Policy adopted in October 2020. See copy attached.
- 2. Areas burned in the August Complex Fire that have residual fuels after the salvage logging operations by Morris Logging.
- 3. Remaining District property that was not burned by the August Complex Fire.

CAL FIRE Humboldt – Del Norte Unit Chief, Kurt McCray, will attend our meeting to answer any questions that the Board may have about the terms and conditions of the contract.

Staff Request

Staff requests that the Board authorize staff to sign the attached contract with CAL FIRE in the amount of \$500,000 to conduct fuel reduction activities as defined in the contract scope and rescind the authorization of February 11, 2021 to enter into a \$200,000 contract for fuel reduction.

9.8 CAL Fire contract

Staff received an opportunity from CAL Fire to conduct fuel reduction activities for defensible space at Ruth Lake, with CAL Fire paying the District approximately \$200,000 to conduct fuel reduction on the District's 3,000 acres at Ruth. District Counsel will confirm that the District can sole source this work. Staff would likely utilize the services of Morris Logging, who is contracted for the services for the wildfire salvage logging, to mulch the smaller scale items, and an air curtain incinerator for the rest. The time constraint is that the contract must be signed by Friday (tomorrow). Without this opportunity for funding, the District's cost could be spread out for several years in the budget; and both lease lots and non-lease properties are involved.

The Board adjourned for lunch at 11:56am and reconvened at 1:00pm.

Staff discussed the possibility of needing a timber harvest permit, but for fuel reduction there likely is a short form. Counsel noted exhibit A shows the deliverables from the District, which include chipping, grinding, burning and transportation of the materials. Soliciting and enlisting professional services are needed as well, and are the District's responsibility. The defensible space policy passed by the Board ensured that lease lot holders will have a role in the process, as well. The work completion date is June 30, 2022.

A concern was voiced that without a limit on the diameter of trees, it incentivizes the commercial logger to take everything. Clear parameters should be added to the agreement to prevent that. Staff clarified that the timeframe is due to CalFire's need to encumber the funds this fiscal year, or lose access to the funds. Additional funding opportunities may arise if we are able to partner with CAL Fire.

EXHIBIT A (Scope of Work)

SCOPE OF WORK

1. Humboldt Bay Municipal Water District (HBMWD) agrees to provide to Department of Forestry and Fire Protection (CAL FIRE) professional services to support CAL FIRE fuel reduction activities as described herein:

HBMWD is to provide professional operational service support to CAL FIRE's Humboldt-Del Norte (HUU) Unit by providing professional fire prevention service contractors to implement tree thinning and pruning, chipping, grinding, and burning of forest fuels as well as transportation of by-product created by fire prevention activities.

The Agreement may be amended to increase services at the rate(s) specified in Exhibit B, Budget Detail and Payment Provisions.

- 2. The services shall be performed at various locations in western Trinity County in a manner to minimize travel costs and maximize workload effectiveness associated with this contract and related fire prevention project activities
- 3. Services shall be provided during normal business hours, Monday through Saturday, excluding State Holidays, when weather and soil conditions minimize potential for adverse environmental impacts.

EXHIBIT A Attachment 1 (Detailed Scope of Work)

DETAILED SCOPE OF WORK

- The HBMWD shall be responsible for soliciting and enlisting qualified professional service personnel as needed by CAL FIRE. Professional services personnel shall be established to minimize expenses, including travel expenses, affiliated with CAL FIRE directed workload. Services will include implementing tree thinning and pruning, chipping, grinding, and burning of forest fuels as well as transportation of by-product created by fire prevention activities.
- 2. Current forest conditions, including damaging wildfire impacts from the August Complex have created a significant need to increase the pace and scale of forest management activities in and around the areas of the community of Ruth as well as Ruth Lake. To effectively implement these activities projects must undergo environmental review in compliance with the California Environmental Quality Act (CEQA). CAL FIRE does not currently have the resources to effectively address a majority of this increased need and workload.
- 3. HBMWD will help allow CAL FIRE to more effectively increase the pace and scale of critical fire prevention management at a landscape-level within the areas in and adjacent to the Community of Ruth as well as Ruth Lake in western Trinity County. Work will be completed over a three-year timeline and work product deliverables will include processed and/or burned forest fuel as well as the transportation of project by-products including biomass and wood chips in compliance with CAL FIRE policy and procedures as well as California State law.
- 4. HBMWD professional will be evaluated based on the adequacy of documentation provided to CAL FIRE and fire prevention project activity evaluation by CAL FIRE personnel. Documentation must meet Departmental standards to facilitate compliance with CEQA and other pertinent laws to facilitate project permitting as determined by CAL FIRE as well as financial documentation as required by CAL FIRE and The State of California.
- 5. HBMWD personnel and/or contractors may perform all, or portions of, CAL FIRE's tasks associated with environmental compliance, project development and implementation as follows:
 - A. Environmental Compliance: Complete CAL FIRE environmental CEQA checklist, complete environmental surveys and archeological reports to complete CEQA compliance; develop prescribed burn plans, smoke management plans and other necessary documentation for prescribed burn project approval.
 - B. Project Development: Conduct public outreach, initiate landowner's contacts, complete landowner access agreement, identify project boundaries, identify sensitive resources within project areas, develop mitigations or Best Management Practices, conduct mapping and analysis and finalize management plans as required.
 - C. Project Implementation: Act as Project Manager on behalf of CAL FIRE, provide project oversight; provide operational direction to contractors or resources completing forest management and reforestation activities. Monitor project activities, collect data, and develop final reports on implementation and effectiveness.
- 6. Travel associated with environmental compliance, project development and project implementation activities will be billed at the State's current mileage rate for the year.

EXHIBIT B (Budget Details and Payment Provisions)

BUDGET DETAIL AND PAYMENT PROVISIONS

1. Invoicing and Payment

A. For services satisfactorily rendered and upon receipt and approval of the invoices, the CAL FIRE agrees to compensate the HBMWD for actual expenditures incurred within the entire contract amount as follows:

2. Budget Contingency Clause

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State or offer an agreement amendment to Contractor to reflect the reduced amount.

3. Clause Advance Payment

Costs for this Agreement shall be computed in accordance with State Administrative Manual Sections 8752 and 8752.1.

Nothing herein contained shall preclude advance payments pursuant to Article 1, Chapter 3, Part 1, Division 3, Title 2 of the Government Code of the State of California.

4. Recovering Receivables from Another State Department

In accordance with Government Code Section 11255, this agreement provides a process for non-payment. In the event that an invoice is not paid by the due date and the invoice is not in dispute, a 30-day notice shall be issued to the debtor department that a transfer of funds will be initiated. This transaction request will be prepared in accordance with the Department of Finance Budget Letter 10-10.

EXHIBIT D (Special Terms and Conditions)

SPECIAL TERMS AND CONDITIONS

1. Confidentiality

- A. All data and information related to CAL FIRE operations, which are designated confidential by CAL FIRE or developed by the Contractor and deemed confidential by CAL FIRE, shall be properly safeguarded and protected by the Contractor from unauthorized use and disclosure. At a minimum, during non-working hours, CAL FIRE paper and or electronic documents, reference materials, or any materials related thereof shall be kept in a locked, secure place. All electronic data shall be password protected and secure at all times.
- B. The Contractor and his or her employees are hereby considered agents only for confidential data purposes and will be liable under the State and Federal statutes for unauthorized disclosures. In the event of subcontracting, the subcontractor and its employees will also be considered agents only for confidential data purposes and will be held liable under said State and Federal statutes.
- C. The Contractor and all subcontractors shall immediately notify the CAL FIRE Project Representative of any request from a third party for disclosure of any information relating to this agreement, including, but not limited to, subpoena, deposition proceedings, court order, Public Records Act Request, or other legal action. Unless the CAL FIRE Project Representative authorizes the disclosure of the information in writing, the Contractor will coordinate a response to any such request with the CAL FIRE Project Representative, exempting or redacting this agreement to the maximum extent permitted by law. Each party will be responsible for their own costs.

2. News Releases and Publicity

The Contractor shall not issue any news release or make any statement to the news media regarding the operational procedures of this Agreement, the meetings or decisions related to this Agreement, or to the status of work related to this Agreement without prior written approval of CAL FIRE.

3. Audit

Agreements involving the expenditure of public funds in excess of \$10,000 are subject to the examination and audit by the State Auditor for a period of three (3) years after final payment under the agreement (GC § 8546.7).

ADDITIONAL PROVISIONS

1. Right to Terminate (SCM 7.85)

The State reserves the right to terminate this agreement subject to thirty (30) days written notice to the Contractor. Contractor may submit a written request to terminate this agreement only if the State should substantially fail to perform its responsibilities as provided herein.

However, the agreement can be immediately terminated for cause. (Refer to GTC, Exhibit C, Item 7. Termination for Cause)

Fire Defensible Space for Buffer Strip Lease Lots

Approved by: Board of Directors, October 28, 2020

A. Background and Policy:

- a. The Board of Directors of the Humboldt Bay Municipal Water District finds and declares that the protection of District Property and Ruth Lake against the hazards of fires is critically important and that person leasing District Property in and around Ruth Lake bear the primary responsibility to maintain their lease premises against the hazards of fire, including maintaining defensible space.
- **b.** California Public Resources Code Section 4291 requires, in part, that: "persons who owns, leases, controls, operates, or maintains a building or structure in, upon, or adjoining a mountainous area, forest-covered lands, brush-covered lands, grass-covered lands, or land that is covered with flammable material, shall at all times do all of the following:
 - 1. Maintain a defensible space of 100 feet from each side and from the front and rear of the structure, but not beyond the property line except as provided in paragraph (2)...
 - 2. A greater distance than that required under paragraph (1) may be required by state law, local ordinance, rule, or regulation..."
- c. The District acknowledges that creating a fire defensible space around Lease Lot structures surrounding Ruth Lake in the area known as the Buffer Strip reduces the threat of wildfire to people and property.
- **d.** The District acknowledges that FEMA and Cal Fire have created guidelines for individuals to create a fire defensible space.
- e. Accordingly, Lease Lot holders shall at no expense to the District, without prior written authorization, create a fire defensible space around their structures at Ruth Lake in accordance with the guidelines published by FEMA and Cal-Fire, copies of which can be obtained from the District, and in accordance with the California Public Resources Code section 4291 et seq. Notwithstanding the foregoing, to the extent maintaining defensible space requires the removal of any timber from the leased premises, the leaseholder shall obtain prior written approval from the District before any such trees are removed. Any tress removed with or without the permission of the District shall be and remain the property of the District.
- **f.** In determining which trees to remove to create a fire defensible space, the District will use the guidance provided by FEMA, Cal Fire and other appropriate resources on a case by case basis factoring in topography, erosion potential, impacts to water quality, and any other relevant sitespecific conditions.
